OLD BUSINESS: D. Ricci Reported that our Attorney R. Braslow Reported that our Local Finance Board Application was approved at the NOV. 13th Meeting. This 400,000.00 loan from Newfield Bank was OK'd.

We issued a P.O. # 617 to Pierce Manufacturing for the purchase of the new Fire Truck. At a cost of \$66,388.00. It will be a 2014 Model year Arrow XT Heavy Duty Rescue pumper. Per Sam Savino the Pierce salesman it should be delivered in 10-months.

We worked on the 2014 Budget, and finalized it at \$66,388.00 with \$33,125.00 to be raised by

W. Cosiglia gave Report on the generator. Installation was almost all done. The State Inspector need to come back for the final inspection and Cooper Elec needs to come down and assist us on the operation.

A discussion was held on getting a few gift certificates for 2- ~~people~~ people that did some under ground work for us on the generator at no charge \$100.00 for Spezini. And also a 200.00 gift certificate for part installation of the generator. Motion made by L. Ricci and by W. Cosiglia to get these gifts.

NEW BUSINESS: W. Corsiglia Road Resolution 13-13.

Awarding Contract for purchase of a Heavy Duty Rescue Pumper to Pierce Manufacturing, Inc. SEE Attached Motion made by R. Maglough Jr. to Approve Resolution and L. Ricci. With all Members voting in the Affirmative D. Ricci - YES, L. Ricci - YES, K. Melinelli - YES, R. Maglough Jr - YES, W. Corsiglia - YES.

We reported that we had placed a public notice in the newspaper reporting of our intent to award contract to a National Cooperative Purchasing Agreement for a full size 6-man rescue pumper.

The contract was signed with Pierce Manufacturing. We just waiting for the performance bond to arrive from Pierce and then we will turn over the (2) checks to Pierce, one from our checking account capital improvements for \$206,388.00 and the check from Newfield Bank for \$100,000.00.

M. Corsiglia mentioned that we need to replace the (8) fires on the back of the Parker since they are 12-years old approx cost \$4,000.00. Also he still needs to get the 3 sets of furniture gear that were approved earlier in the year, cost about \$1,000. Motion to purchase by R. Maglough Jr - and by L. Ricci

D. Ricci mentioned that he had met with ASJ. over Burglar Alarm Co. Regarding the possibility of installing some cameras in the building if we leased this equip it would be \$4,500.00 up front with a monthly fee of \$600. It was decided to discuss further with the Firemen and the Rescue Squad.

A discussion was held on having a new new girl scout troop use the firehouse once a month and (1) of the fire fighter would be there with them. It was decided that we would let them use it for (6) month. Trial and then see how it is working out.
