OLD BUSINESS:

D. Ricci mentioned that he was still working on trying to get the electric bill lower which involved in talking to Atlantic City Electric and Electrician.  
D. Ricci also reported that he was still working with Capri Construction on the problem with the front glass overhead doors leaving also in getting some lights repaired.  
Chief M. Corsiglia reported that he was still working on the pump for the tanker.

Discussion was had on maybe buying a storage shed for the back yard. The Commission decided that they would hold off on that for this time and maybe the firemen would purchase it instead.

M. Corsiglia reported that the annual Commission and Budget Election was held on FEB 16th and that the Budget was passed, and that the public question the purchase of a new fire pump truck also passed. D. Ricci was a lone candidate for Commission and he was also elected.

NEW BUSINESS: Discussion was held on LENDING the Chief. VEHICLE, Motion made by L. Ricci and by R. Panlunghi to get it LENDED.  
D. Ricci also suggested that there should be limitations on the use of the car. EX: Who can drive it, what exactly it can be used for. Chief Corsiglia stated he would set up guidelines.  
Discussion was held on LENDING F-125 the utility truck that pulls the County's Tanker task Force trailers. The truck is not LENDED at this time. Decision was made to NOT LEND it until next year. See if next year. Maybe we could convert F-120 to that job.

Discussion was held on the some of the Firemen that obtain a CID license, what we would reimburse them if they that passed the test.  
All members present voted in the Affirmative.

D. Ricci mentioned that we need to pay C. Furchill Engineering for the "AS. Builder Drawings" cost is \$1,600.00. We need those drawings in order to get our deposit back from Atlantic County. Motion made by L. Ricci and R. Panlunghi to pay them.

Chief Corsiglia asked for OK to purchase accountability tags at a approx. cost of \$350.00. Also 2 chains for chain saws.  
Motion made by L. Ricci and by R. Panlunghi to approve purchase.
