OLD BUSINESS:

M. Corsinia Reported that the old truck fires that we were storing in the sheds are now gone which should give us room in there now.

M. Corsinia had prices for the light weight gear. They would be \$1,250.00 per set for the best price. Also he had a good price for 2-regular sets of full turnout gear (FireDex Brand) @ \$2,128 - per set. These will be purchased from Jessy Fire & Safety Products LLC. Motion made to purchase L. D. Ricci reported that he was still getting the prices on additional cameras in the building, need (3) - more.

M. Corsinia gave report on new truck is here but will need to go back to Fire & Safety for equipment installation and will not go into service for another month due to mounting all of the equipment. M. Corsinia reported that he received the contract from CASTLE ENERGY and had forwarded it to our attorney for review.

D. Ricci mentioned about firemen being able to use the building for immediate family events, a discussion was held but the discussion will go to the firemen at their meeting and their suggestions will be discussed at a future meeting.

D Ricci mentioned that we could have a couple more of the heavy rubber mats for under the desks, M. Cassiglia said check at Fazzio's for them.

M. Cassiglia had prices for the new pump on quote F-1223 approx price of \$15,461.00 for the Dartsley Co. All members present were happy with this price and the project going ahead. This pump replacement will finally get this 3-yr old project going. He will obtain a fine quartz from them. M. Cassiglia will have the S.C.B. Refill serviced in Dec. Also F-1223 should have the pump serviced for approx cost of \$425.00 from Fire + Safety. Also the washing machine NEED to be serviced.
