OLD BUSINESS:

D.Ricci reported that all CD's were cashed in at Newfield Bank on 2/22/23 The monies will be put into the checking account until needed to send to Pierce MFG/Fire and Safety Services.

M.Panco reported that D.Ricci will be handling the Lease Purchase financing with Community Leasing in Manhattan KS

D.Ricci reported that all commissioners are now set up to sign the checks thru Newfield Bank.

M.Panco reported that we are still working on our mutual aid agreements for our local mutual aid companies, Waiting for Mays Landing which should be done soon.

M.Corsiglia reported that Training officer J.Kline is still working on getting chainsaw training in the future. In house driver training still needs to be done. Right to know training was completed on 2/27

M.Corsiglia advised the air compressor for the SCBA system has not been serviced yet. We have sent a air sample out to get tested. We are still researching service or finding out what's involved (maybe we can do the service)

M.Corsiglia also advised that the vinyl lettering on F-1222's trailer is starting to look bad and F-1221's gold leaf needs to be varnished approximate cost for the varnish is \$600.00 He will work on some pricing for F-1222.

M.Corsiglia reported that that tank fill valve on F-1223 has been repaired.

M.Panco reported that he will be repairing the battery powered emergency lights.

We will be exploring some ideas for a well on the property and getting prices. D.Ricci had a quote from Quinlan Well Drilling for a complete 6" well for \$26,000.00, that is the largest that they can drill, 6" it is too small for our needs. We will pursue other drillers.

M.Corsiglia reported that the boiler was inspected with no problems. The inspector did recommend that the desiccant filter needs to be changed. We will contact our heater people.

M.Corsiglia had a price of \$750.00 for a new gas meter for this year, but he is still checking on some other options.

M.Panco reported that the motor and controller for the electric positive pressure fan will be repaired under warranty, We are still waiting for the part.

M.Panco will check the Heat pumps for excessive gas and electric usage.

M.Panco reported that our invoices from JR Castle Solar should be more timely in the future..

M.Panco reported that (1) new helmet is in and still waiting for the other (2).

M.Corsiglia that the (3) SCBA face masks are ordered.

M.Corsiglia reported that the 911 TV screen to the right of F-1221 is too small to see clearly from the officers seat. A discussion was held to take the TV from the meeting room which is much larger and put it in the bay next to F-1221 and take the other TV and install it to the right of F-1223 so that officer can see that screen. We will purchase a new 75" TV for the meeting room appox cost of \$1,000.00 Motion to purchase by M.Panco 2nd by D.Ricci.

D.Ricci advised that the check for 2022 qualified members is ready to be sent to Lincoln Financial.
