He has (1) EST for repairs from Finish Line for \$1,800.00 to fill the cracks and coat the parking lot for \$10,000. We will try to get another estimate.

M.Panco reported that the flagpole needs to be repaired the mechanism keeps jamming. He will call Capri Construction to see who works on these.

M,Corsiglia reported that the building water is still causing spotting on the trucks. We will call our soap supplier to see if he has any suggestions.
